# Mann Selected for Inclusion in Who's Who in Economics

Mike Mann is part of a select group of economists chosen for inclusion in Who's Who in Economics (MIT Press, 1983). Mike's principal contributions to economics are described in the volume as follows:

Established, through replication, the consistency of Bain's findings that entry barriers matter importantly in affecting the ability of firms to price persistently in monopolistic fashion. As part of ongoing research with J.A. Henning, attempting to demonstrate that the notion of causal priority provides a potentially significant means by which to uncover causal relationships among industrial organization variables.

## Social Welfare Research Institute Refunded

The Social Welfare Research Institute at Boston College (SWRI), directed by Barry Bluestone, received in September a \$400,000 grant from the U.S. Department of Health and Human Services to continue research and development of the Multi-Regional Policy Impact Simulation model (MRPIS).

Begun in 1980, MRPIS is a large scale microsimulation model of the U.S. economy that mimics the circular flow of income and employment through a household sector, a product market, a multiregional input-output model, and a disaggregated labor market. The model is used to estimate the potential impact on the distribution of income of a wide variety of federal tax, transfer, and expenditure policies. Unlike most econometric models of the U.S., MRPIS is capable of generating simulation results that are state, industry, and occupation specific. Moreover, because the household sector of the model contains information on a large micro-sample of families, it is possible to estimate how tax, transfer, and expenditure policies affect various demographic groups, for example, minority groups or families headed by women.

The 1983 funding will permit the SWRI staff to develop a fully specified Level 2 model based on a prototype constructed during the past two years. The Level 2 model will contain information from the 1982 Current Population Survey and will rely on the construction of a brand new multi-regional input-output matrix. Once complete, sometime before September 1984, the Level 2 model will be ready to answer a broad range of policy questions posed by federal government agencies, members of Congress, and state governments. MRPIS development will be an ongoing project of SWRI with three higher level models planned for the next five years.

The SWRI model is directed by John Havens (Grad Econ) and Barry Bluestone and has on staff a number of current and former BC economics graduate students including Lynn Ware, Alan Matthews, Carol Pepin, and Dan Swaine.
