The Behavioral Health of Venezuelan Families in Diaspora: A Cross-National Study Stress and Resilience

Many Venezuelan crisis migrants are exposed to high levels of stress both before and after migrating. We aim to conduct a definitive study of the Venezuelan diaspora in the US with a comparison sample in Colombia. This study will provide knowledge vital to addressing the immediate and longer-term needs of Venezuelan crisis migrant families and inform responses to future crises.

Our long-term goal is to assist Puerto Rican families in the aftermath of Hurricane Maria. A major part of this goal is identifying intervention strategies to prevent or offset alcohol misuse among adults and youth who went through the storm. We focus our efforts on alcohol misuse based on findings from our epidemiologic research indicating disconcerting levels of alcohol use among island-born Puerto Ricans before the storm and increases in alcohol misuse in response to trauma and migration-related stressors.

Recreational Cannabis Legalization and Prenatal Substance Use Laws: A Mixed-Methods Study

Recreational cannabis laws (RCL) have recently collided with often decades-old prenatal substance use laws that criminalize women's use through punitive measures. Our study will fill vital gaps in understanding the differential impacts of RCL and child protection laws on pregnant women broadly and women from racial and ethnic groups specifically. Our quantitative and qualitative findings will inform policy and clinical practice related to prenatal substance use laws within the shifting context of cannabis legalization.
